Standard Requirement: According to the Environment Conservation Rules 1997, the industrial area noise level should be 75 dBA at daytime and 70 dBA at night-time. According to World Health Organization (WHO), the noise level standard for indoor workplace area is 85 dBA. According to Bangladesh Labor Rules-2015, working in the area more than 80 dBA noise level recognize as hazardous.

Comment: From the assessment it is revealed that the indoor workplace noise levels were found within the acceptable level in most of the sections in comparison to the ECR-1997, Bangadesh Labor Rules & WHO noise level standard except in few areas (marked bold) in the above table. Furthermore, the ambient noise level has been found within the standard limit. Employees are required to use ear plug where values are between 75-85 dBA and earmuff where value is above 85 dBA to minimize occupational hazard.
