Subject: Approval of Waste Co-processing at LafargeHolcim Bangladesh Limited Plant. Ref: Your letter dated 10/08/2010, 15/09/2009 and 11/10/2017.

With reference to your letter and subsequent correspondences on the subject mentioned above, the Environmental Clearance Committee of the Department of Environment (DOE), Head Office, in its 316th meeting at no. miscellaneous-2 decision dated 02/11/2017, decided to issue the approval of Waste Co-processing in favor of LafargeHolcim Bangladesh Limited at Chhatak, Sunamganj under the following terms and conditions:

- 1. The plant should have comprehensive risk management plans, like spillage control and management plan, Emergency Response Plan (ERP) etc. Initially a copy of each plan should be provided to both Sylhet divisional office and head office of department of environment.
- 2. The plant should maintain inventory of the waste tonnage received, tonnage used, tonnage existing on site etc.
- 3. The plant should maintain the Waste Acceptance Criteria as submitted to department of environment (DoE).
- 4. The plant should have covered shed with concrete flooring for storing waste used for co-processing.
- 5. The plant should have a provision for secondary containment in case of oil spillage at storing point.
- 6. The plant should have proper storage facility which adheres the requirements of
  - i. necessary labeling indicating waste type
  - ii. declaring non smoking area, no food and drink etc
  - iii. showing telephone number to inform in case of emergency etc
  - iv. route, emergency plan and procedures in case of spillage
- 7. The plant should ensure that the operation is in accordance to the terms and conditions of the Single Consolidated Environmental Clearance for the LafargeHolcim Bangladesh Limited provided vide mem no. PA/CB(SH).PRA/Chharpatra)-214/2007/480 dated 08 April, 2008.
- 8. This Approval shall render void the earlier Co-processing Approval on 18/10/2010 memo. DoE/Clearance/4058/2009/345.

Violation of any of the above mentioned (1 to 8) conditions shall render this permit as void and legal action will be taken as per Bangladesh Environment Conservation Act 1995 (amended 2010) and Environment Conservation Rules 1997.
